As per the order cited 1<sup>st</sup> above, Government of India have allotted **148.55 MT of RICE & 63.67 MT of WHEAT** to the state per month under Welfare Institutions Scheme @ BPL Central issue Price for the period from April-2017 to September-2017. The General Manager, FCI has informed that, the entire amount against the allocation is to be remitted by the State Government in to FCI Account. Hence the Cost of foodgrains due to FCI @Rs. 5650/- per MT for Rice and Rs. 4150/- per MT for Wheat for releasing the stock of Welfare Allotment will be paid to FCI via RTGS.

Validity for lifting of stock **on or before 15-07-2017**

The General Manager, FCI, Thiruvananthapuram will ensure that sufficient quantity of good quality foodgrains is made available in all depots well in advance and issued to the DSOs/TSOs of Government of Kerala.

The District Supply Officers are directed to arrange lifting of the entire stock and issue in accordance with the permits. The monthly lifting and off-take details should be communicated to this office at the earliest.
